

# ***WISD HALL OF HONOR NOMINATION CRITERIA***

## ***QUALIFICATION FOR INDUCTION***

- **GENERAL QUALIFICATION:** Each Individual athlete must be a graduate of Wylie ISD and must have participated as a student in the WISD athletic program. All individuals and their team members considered for induction must be of outstanding moral character.
  
- **INDIVIDUAL QUALIFICATION:** To be qualified for individual induction in sports, the candidate must meet at least one of the following criteria:
  - (a) Recognition as a first or second team All State team member or selected as a participant in a recognized coaches association All Star Game.
  
  - (b) Participated in athletic competition at the college and/or professional level.
  
  - (c) Named to a first team All District in at least two sports for two years or three years in one sport. (Example: soccer 2 years, softball 2 years or 3 years basketball, ect.)
  
- **TEAM QUALIFICATION:** For the sports deemed TEAM SPORTS qualifications must include no less than regional championships as determined by University Interscholastic League play-off systems. Certain team sports including cross-country, track and field, golf, and tennis must have been State qualifiers.
  
- **COACHES QUALIFICATION:** Consideration for induction by coaches who have demonstrated success not only with the win/loss record but also with purpose, goals, and loyalty to WISD and Wylie ISD athletic program. To be considered for induction the candidate must meet at least one of the following criteria:
  - (a) Winners of State Championships.
  
  - (b) Participate in no less that five playoff appearances.
  
  - (c) Continuous athletic tenure in Wylie ISD for a period of no less than fifteen years.

**TIME REQUIREMENTS:** All coaches must wait a minimum of five years after

meeting the above criteria before being considered for induction.

- **OTHER INDUCTEES:** Sports being part of the total education process would not be possible without community support. It is therefore mandatory that consideration be given to identifying and inducting those individuals in the community that have been exemplary in their support, loyalty, and devotion to the students involved in the athletic program. Candidates must meet at least one of the following criteria:
  - (a) Serve a minimum of ten years in a sports related activities.
  - (b) Provide extreme financial assistance as deemed beyond normal contributions that will enhance sports activities in WISD. (excluding advertisements)
  - (c) An individual, business, or group that through the years has been exemplary in their support, loyalty, and devotion to the students and the athletic program.

***ONLY ONE INDUCTEE PER FIVE YEAR PERIOD WILL BE CONSIDERED IN THIS CATEGORY***

- ***FINAL SELECTION VOTING: Individuals and teams will be selected by TWO-THIRDS MAJORITY vote of The Executive Board of Governors. The Executive Board of Governors shall consist of no less than eight members as established by Article IV, Section 1, Wylie Sports Hall of Honor By Laws.***
